# Newlin Township Board of Supervisors Re-organizational Meeting

# January 3, 2017

**Call to Order:** The 2017 yearly re-organizational meeting of the Newlin Township Board of Supervisors convened at 8:00 p.m. at the The Newlin Township Maintenance Garage located at 1751 Embreeville Road, Coatesville, Pa. Present were Janie Baird, Robert Pearson, Bill Kelsall and Secretary, Gail Abel.

# Comment Period: No comments.

# **Organize:**

Gail Abel, Secretary opened the meeting, and announced this meeting was advertised in the DLN on January 6, 2016 along with the 2016 meeting schedule.

There are no new members to take the Oath.

Secretary asked the Board for a motion to elect a temporary Chairman. Bob Pearson made a motion to elect Bill Kelsall as temporary Chairman, seconded by Janie Baird and the motion was approved.

Janie Baird made the motion to use BB&T as our depository for the Township's General Fund Account, Meridian Bank for General Fund Savings Account, DNB First for Embreeville Building Fund, Key Bank for General Fund Savings Account and Citizens Bank for the Escrow Fund and Fire & EMS Account, TD Bank for Open Space Fund, Fire & EMS Tax Account, Land Acquisition and The State Liquid Fuel Fund; Bill Kelsall seconded and the motion was approved.

### Appoint Employees-set wages:

Bob Pearson made the motion to increase Robert Sexton's wages to \$18.50 per hour, seconded by Bill Kelsall and the motion was approved.

### **Appoint Road Master:**

Bill Kelsall made the motion to appoint Bob Pearson as the Road Master, seconded by Janie Baird and the motion was approved. Wages were declined by Mr. Pearson.

### **Appoint Auditor:**

Auditor is an elected position. Janie Baird said Scott Hedgepeth will have to run for a full 6 year term in this year's election. He had been a 2 year fill when Scott Roney retired.
